4. Your set and technical requirements need to be kept to a minimum in order for your performance to run smoothly and to schedule.
5. In case of cancellation after the YAF promotional material goes to print, the group MUST:
  - Inform the YAF office immediately.
  - Send cancellation press release to the press and media.
  - Be at the venue to handle all enquiries.
6. YAF reserves the right to edit and use the publicity materials that your group provides and the

performance photographs of your group.

7. The information provided will be used for administration and publicity purposes only.

- Bear all performing costs
- Provide accurate information regarding your performance
- Provide information for producing promotional materials of the event
- Update your contact information with YAF
- Work cooperatively with YAF and the venue technical team
- Promise to do your best to promote your show to get an audience
- Be punctual for the performance
