Venue: Outdoor performance venue

Performance Type: Suitable for dance, music, magic, rope-skipping,

acrobatic performances and more

Production Flow: No rehearsal/stage entry procedures

• Performance Duration: Each performance must not exceed 8 minutes, yet you

may sign up for two performance programmes (max)

• Theme: The theme of the performance should be suitable for all

ages and should not contain any vulgar language or

adult topics

Performers' Age: Performers must be between the ages of <u>8 and 25</u>

• Number of Performers: Minimum 2 performers, maximum 30 performers;

soloist is not accepted

Stage Size: Approximately 14 meters long x 8 meters deep

• Stage Floor: Carpeted wooden floor (not Marley floor)

- For Music Performance Groups/Choirs:
  - The following audio equipment can be provided:

Wireless microphones: up to 6
 Microphone stands: up to 6
 Chairs: up to 2

- The following equipment must be prepared by the performance groups (if applicable):
  - Music stands
  - Additional chairs needed/instrument-specific chairs
  - Musical instruments
- For groups that include musical instruments, the setup should be simple and ready within 5 minutes.
- Our emcees will introduce your group and piece before your performance begins. If you need narration during your performance, please mention it in the application form for approval.

#### **IMPORTANT NOTES**

- 1. The group representative is responsible for checking emails from HKYAF regularly. All related materials and information will be given out via email.
- 2. The group representative is responsible for relaying all terms & conditions to the members of their group.
- 3. Please provide a link to your latest performance video in your application. The number of performers, quality and style should be similar to the piece you plan to perform at the event.
- 4. Please provide us with a video of your final rehearsal for our technical team's reference at least <u>three weeks</u> before the performance date.
- 5. Keep your set and technical requirements to a minimum for smooth performances.
- 6. In case of cancellation after HKYAF's promotional material goes to print, the group MUST:
  - i. Inform the HKYAF office immediately.
  - ii. Send cancellation press releases to the press and media.
  - iii. Be at the venue to handle all enquiries.
- 7. HKYAF reserves the right to edit and use the publicity materials that your group provides and the performance photographs of your group.
- 8. The information provided will be used for administration and publicity purposes only.
- 9. HKYAF reserves the right to cancel the performance due to large-scale public order events, adverse weather or other emergencies on the event dates. Should there be such changes, HKYAF will be in touch with the contact person of each performance group with the relevant information.

#### YOUR GROUP SHOULD

- Bear all the performing costs
- Provide accurate information regarding your performance
- Provide information for producing promotional materials for the event
- Notify HKYAF of your up-to-date contact information
- Work cooperatively with HKYAF and the venue technical team
- Promote your show to get an audience
- Be punctual for the performance
